

## REFINED BY FIRE: FIRE WIVES RETREAT TERMS AND CONDITIONS

Refined by Fire agrees to provide services and/or professional recommendations as follows:  
Agrees to facilitate the booking of travel (overnight accommodations and itinerary for this retreat).

Collect the payments and apply that payment on your behalf towards the trip costs.

Create a Facebook group for your retreat, to which each attendee may communicate directly about the plans.

Attendee(s) agrees to the following:

Give her due diligence to relevant travel warnings.

Agrees take responsibility for completing travel specific duties.

Follows the rules and regulations set forth by both the hosts and the lodging party.

They will be sharing a room with other women during their stay. Room types and bedding arrangements vary, so attendees may have to share a bed with another attendee. The beds will be randomly assigned. But they will be given a bed with the person whom they are traveling with- if you are traveling with someone.

Purchase their own airfare (if applicable)

Agrees to no smoking, drinking, drugs, or other substances while on this trip due to sharing a room and possible bed with other people.

### RIGHTS AND RESPONSIBILITIES:

The attendee has the right to choose not to proceed with any travel arrangements within reason and requirements to follow. In the event that a client can no longer travel, all monies paid will be refunded once your spot has been replaced by another client. If a client's spot is not filled, the client is responsible for the remainder of their balance. Refined by Fire will do their best to help find a replacement for the attendee in the event they need to cancel. Upon cancellation, attendees are subject to a \$75 cancellation once a spot is filled.

Refined by Fire has the right to terminate this trip at any time for any reason, but will return the money to you in a timely manner once refunded by the supplier if this occurs. They will also notify guests of this decision in a timely manner.

### PHOTO RELEASE:

The attendee has a right to choose to allow release of photos of them from the trip taken by Refined Fire Hosts or other travelers for purposes of advertising future trips, to place on websites and/or any affiliated Facebook groups, and other options as seen fit by Refined by Fire. In order to opt out, the attendee must submit a written statement prior to attending the retreat and send to the current host(s) of the Refined By Fire retreat stating they would like to opt out of photos for the current retreat as listed in this agreement.

The attendee authorizes Refined by Fire to act as my host(s) for the trip as indicated in the documents, brochures, correspondence or other communication that will be used for travel. Attendee understands these suppliers are responsible for providing the travel services purchased.

Refined by Fire will advise attendees of the refund policy change and cancellation fees and penalties. Attendee is responsible for booking and managing their air travel (if applicable). Travel Insurance is available upon request.

Attendee releases and forever discharges Refined by Fire and any hosts, affiliates, or otherwise from any and all claims, demands, damages, actions, cause of actions of suits of any kind or nature whatsoever, which I may have now or hereafter, arising out of or in any way relating to any and all injuries and damages of any and every kind, to both person and/or property, and also any and all injuries and damages that may develop in the future as a result or related to in any way for the travel on this retreat.

Each attendee is responsible for their room's tidiness and any damages or destruction that may occur. If damage is created due to one person, that person is fully responsible for any charges or fees that may be incurred during the stay as a result of something they did or did not do. If the damage is created equally amongst people in the room, costs and liability will be split equally amongst parties involved. I hereby release Refined by Fire of any costs that may be incurred during the event of the stay or hereafter.

Attendee will review the travel documents upon receipt for accuracy. Attendees may contact Refined by Fire with any questions at any time during daytime hours. Attendee agrees with the above terms and conditions and appoints Refined by Fire to manage all plans on their behalf.
